

Subject : Recommendation to Issue Board Resolutions Approving in Principle the Procurement of Items for the National Museum Collections

This is for the purpose of recommending to the Board of Trustees the approval in principle of the procurement of heritage assets and collections items for the National Museum Collection pursuant to Section 22 of Republic Act No. 11333.

The owners of the foregoing heritage assets and collections items have made written offers to the National Museum, with quotation, for the sale thereof, and after due evaluation and ascertainment of their appropriates significance to the National Museum and importance to the heritage and patrimony of Filipino people, as well as the conclusion of negotiations wheremat the price quotations were found fair and reasonable, the Director-General deems it necessary to acquire these heritage assets and collections items through direct negotiation:

- I. Original Works of Art
 - a. Nine (9) original works of art of Jeremias Elizalde Navarro, National Artist for Visual Arts, offered for sale by the owner, Ms. Pearl Navarro, for the amount of Four million two hundred fifty thousand pesos (P 4, 250, 000.00 Philippine currency). *Please see attached letter of Ms. Pearl Navarro.*
 - b. Thirty nine (39) original works of art of Jeremias Elizalde Navarro, National Artist for Visual Arts, offered for sale by the owner, Ms. Emma Navarro, for the amount of Eight million eight hundred thousand pesos (P 8, 800,000 Philippine currency). *Please see attached letter of Ms. Emma Navarro.*
 - c. Three (3) original works of art of Lauro Zarate Alcalá National Artist for Visual Arts, offered for sale by the owner, Ms. Angela Espiritu, for the amount Five hundred fifty thousand pesos (P550, 000.00). *Please see attached letter of Ms. Angelu Espiritu.*

II. Textile Heritage of Panay

Consists of various sets of *Patadyong*, *Pinilian*, *Panubok*, *Barong Tagalog*, *Filipiniana*, and pure piña, hand embroidered piña-seda cloth, and embroidery materials from Miag-aq, Iloilo, Bugasong, Antique, Panay-Bukidnon (Antique and/or Iloilo, and Aklan) offered for sale by the owner-manger of Dela Cruz House of Piña, Ms. Rhodora Dela Cruz-Sulang, for the amount of One million five hundred thousand pesos (P 1, 500,000.00 Philippine currency). Please see attached letter of *Rhodora Dela Cruz-Sulang*:

III. *Piloncitos*.

Thirty seven (37) pieces of gold (electrum) *Piloncitos* weighing 69.9 grams offered for sale by the owner, Mr. Danilo Barba Mathews, for a lot price of One million four hundred thousand pesos (P 1, 400,000.00). Please see attached letter of *Mr. Danilo Barba Mathews*.

Given these considerations, I hereby recommend that the purchase of these heritage assets and collections items be approved in principle by the Board of Trustees and request that said approval be embodied in corresponding Board Resolutions in accordance with Section 22 (c) of Republic Act No. 11333, viz:

SEC. 22. Procurement of Items for the National Museum Collections. – The procurement of unique, special and/or original items by the National Museum charged to any of its sources or funds as may be allowed, and authorized by the Head of Agency and concurred by the Board, shall be exempted from applicable laws, rules and regulations regarding government procurement.

The National Museum, as a general rule, shall be allowed to procure collections items by means of direct negotiation with the owners of such items, or their duly designated agents or representatives, in the Philippines, or abroad, as follows:

- (a) A written signed quotation for the sale of the item(s), shall be issued and addressed to the National Museum by the owner, or his or her agent or representative;
- (b) A certification that the item to be acquired is of appropriate significance to the National Museum and of importance to the heritage and patrimony of the Filipino people, that the negotiated price is reasonable and fair, that no conflicts of interest as may be defined by prevailing laws, rules and regulations exist and that the item in question has not been illegally acquired or trafficked, shall be issued by the Head of Agency;
- (c) For items above One million pesos (P 1,000,000) or its foreign equivalent in price, the Head of Agency shall recommend in writing to the Board the issuance of a resolution for the approval in principle of the transaction; items under this amount may be procured upon the sole authority of the Head of Agency provided that there is no "splitting" as defined in pertinent procurement laws, rules and regulations;
- (d) A resolution of the Board approving in principle the purchase of the concerned item by the National Museum and authorizing the signing by the Head of Agency of a Deed of Sale as well as all other documents to the transaction shall be issued for items above One million pesos (P1,000,000) or its foreign currency equivalent in price;
- (e) xxx xxx xxx;

Hence, this recommendation for consideration and appropriate action of the Board of Trustees.

RESOLUTION NO. 10-2020

APPROVING IN PRINCIPLE THE PROCUREMENT OF ITEMS FOR THE NATIONAL MUSEUM COLLECTIONS - ORIGINAL WORKS OF ART OF NATIONAL ARTISTS FOR VISUAL ARTS JEREMIAS ELIZALDE NAVARRO AND LAURO ZARATE ALCALA

WHEREAS, Section 22 of Republic Act No. 11333 authorizes the procurement of items for the National Museums Collections through direct negotiation and empowers the Board to approve the procurement in principle, thus:

SEC. 22. *Procurement of Items for the National Museum Collections.* – The procurement of unique, special and/or original items by the National Museum charged to any of its sources or funds as may be allowed, and authorized by the Head of Agency and concurred by the Board, shall be exempted from applicable laws, rules and regulations regarding government procurement.

The National Museum, as a general rule, shall be allowed to procure collections items by means of direct negotiation with the owners of such items, or their duly designated agents or representatives, in the Philippines, or abroad, as follows:

- (a) A written signed quotation for the sale of the item(s), shall be issued and addressed to the National Museum by the owner, or his or her agent or representative;
- (b) A certification that the item to be acquired is of appropriate significance to the National Museum and of importance to the heritage and patrimony of the Filipino people, that the negotiated price is reasonable and fair, that no conflicts of interest as may be defined by prevailing laws, rules and regulations exist and that the item in question has not been illegally acquired or trafficked, shall be issued by the Head of Agency;
- (c) For items above One million pesos (P 1,000, 000) or its foreign equivalent in price, the Head of Agency shall recommend in writing to the Board the issuance of a resolution for the approval in principle of the transaction; items under this amount may be procured upon the sole authority of the Head of Agency provided that there is no “splitting” as defined in pertinent procurement laws, rules and regulations;
- (d) A resolution of the Board approving in principle the purchase of the concerned item by the National Museum and authorizing the signing by the

Head of Agency of a Deed of Sale as well as all other documents to the transaction shall be issued for items above One million pesos (P1,000,000) or its foreign currency equivalent in price;

(e) xxx xxx xxx;

WHEREAS, in a letter dated November 25, 2020, Ms. Pearl Navarro, owner of several original works of art of Jeremias Elizalde Navarro, National Artist for Visual Arts, offered for sale to the National Museum thirty-nine (39) original works of art of Navarro for the amount of Eight million eight hundred thousand pesos (P 8,800,000.00);

WHEREAS, in a letter of even date, Ms. Emma Navarro, who also owns several original works of art of Navarro, offered for sale to the National Museum nine (9) of his original works of art for the amount of Four million two hundred fifty thousand pesos (P 4,250,000.00);

WHEREAS, in a letter also dated November 25, 2020, Ms. Ms. Angela Espiritu, owner of three (3) original works of art of Lauro Zarate Alcala National Artist for Visual Arts, offered for sale the said works of art to the National Museum for the amount Five hundred fifty thousand pesos (P550,000.00);

WHEREAS, the Director-General, after due evaluation and ascertainment of the appropriate significance to the National Museum and importance to the heritage and patrimony of Filipino people of the said original works of art, as well as the conclusion of negotiations wherreat the price quotations were found fair and reasonable, made a written recommendation to this Board for the approval in principle of their procurement and the issuance of a Resolution embodying the approval;

NOW THEREFORE, BY ITS AUTHORITY UNDER THE NATIONAL MUSEUM OF THE PHILIPPINES, AND OTHER PERTINENT LAWS AND ISSUANCES, BE IT RESOLVED, AS THE BOARD OF TRUSTEES HEREBY RESOLVES:

To approve in principle the procurement of forty-eight (48) original works of art of Jeremias Elizalde Navarro, National Artist for Visual Arts, and the three (3) original works of art of Lauro Zarate Alcantara.


