

The National Museum of the Philippines will be installing another Hibla ng Lahing Filipino exhibition at the NMP Cordillera Rice Terraces Site Museum and Satellite Office (CRTSMSO) in Kiangnan, Ifugao as part of the Hibla ng Lahing Filipino Program, in partnership with the Office of Deputy Speaker and Representative Loren Legarda. This particular exhibition will feature the shared textile tradition of the different communities in the Cordillera and neighboring groups in northern Luzon.

The Boston Art Gallery in Cubao, Quezon City, owned by Dr. Joven R. Cuanang, exhibited the hand woven and hand embroidered textile/art creations of Ms. Irene Bawer-Bimuyag entitled, *PALIN-AWA: Sacred Ritual Healing Amongst Kalinga*. Ms. Bawer-Bimuyag is a third-generation weaver from Barangay Mabiong in the Municipality of Lubuagan, Province of Kalinga. She works with the Mabiong women weavers using backstrap loom in weaving the *tapis* (wrap-around skirt) and embellishing it with embroidery thereby transforming it into a tapestry of colors, patterns, texts, and healing.

Her designs creations and that of the women weavers that she is working with are unique, representing both traditional and contemporary Kalinga textiles that can be considered as an “art” and an “ethnographic material” worthy to be included in the National Ethnographic Collection of the National Museum of the Philippines.







- c. For items One million pesos (Php 1,000,000.00) and below, may be procured upon the sole authority of the Head of Agency provided that there is no “splitting” as defined in pertinent procurement laws, rules and regulations;
- d. A resolution of the Bids and Awards Committee of the National Museum verifying that the aforementioned documents, where applicable, have been produced, certifying as to the availability of funds, and authorizing the issuance of a Notice of Award pertaining to the purchase of the item(s) for the signature of the Head of Agency, shall be issued”;

WHEREAS, the National Museum of the Philippines intends to **procure three (3) Hand Woven and Hand-Embroidered Textiles / Artworks of Ms. Irene Bawer-Bimuyag**;

WHEREAS, **Mr. Joven R. Cuanang, M.D.**, owner of the aforementioned collection, offered to sell the same to the National Museum for the amount of **Five Hundred Seventy-One Thousand Pesos (P571,000.00 Philippine currency)**. (Please see attached letter of **Mr. Joven R. Cuanang, M.D.**);
