WATERPROOFING WORKS AT WESTERN VISAYAS REGIONAL MUSEUM AND SATELLITE OFFICE (NM ILOILO)

1. The National Museum of the Philippines, through the General Fund FY 2021 intends to apply the sum of Two Million Six Hundred Ninety-Four Thousand Pesos (PHP 2,694,000.00), being the Approved Budget for the Contract (ABC), to payments under the contract for WATERPROOFING WORKS AT WESTERN VISAYAS REGIONAL MUSEUM AND SATELLITE OFFICE (NM ILOILO). Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The National Museum of the Philippines now invites bids for the above Procurement Project. Completion of the Works is required within Ninety (90) calendar days. The Contractor must have a Specialty Project – Waterproofing Works (SP-WP) Category C Contractor’s License and must have completed or implemented at least one (1) contract that is similar to the project to be bid, and whose value, adjusted to current prices using PSA consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. Similar is defined as “having completed or implemented a Waterproofing Works”.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

4. Interested bidders may obtain further information from the National Museum of the Philippines Bids and Awards Committee and inspect the Bidding Documents at the address given below from Mondays - Fridays at 9:30 A.M. to 2:30 P.M.

5. A complete set of Bidding Documents may be acquired by interested bidders on 20 August 2021, from the given address below and the website <http://nationalmuseum.gov.ph/> and upon payment of the applicable non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Two Thousand Pesos (PHP 2,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person, or through electronic means.

6. Pre-Bid Conference shall be on 27 August 2021, 9:30 A.M. at Old Civil Service Building, National Museum of the Philippines, Padre Burgos Street, Manila, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before 10 September 2021, at 9:30 A.M. LATE BIDS SHALL NOT BE ACCEPTED.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.

9. Bid opening shall be on 10 September 2021, at 9:30 A.M. at Old Civil Service Building, National Museum of the Philippines, Padre Burgos Street, Manila. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

10. The National Museum of the Philippines reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
