Description

INVITATION TO BID FOR
SUPPLY AND DELIVERY OF VARIOUS LIGHTING FIXTURES – FY 2022

1. The NATIONAL MUSEUM OF THE PHILIPPINES, through the General Fund FY 2022 intends to apply the sum of Three Million Pesos (Php 3,000,000.00) being the ABC to payments under the project mentioned above. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The NATIONAL MUSEUM OF THE PHILIPPINES now invites bids for the above Procurement Project. Delivery of the Goods and Services is required within Fifteen (15) Calendar Days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the NATIONAL MUSEUM OF THE PHILIPPINES BIDS AND AWARDS COMMITTEE and inspect the Bidding Documents at the address given below from Monday – Friday at 9:30 A.M.- 2:30 P.M.

5. A complete set of Bidding Documents may be acquired by interested Bidders on 28 February 2022 from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00) The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, or through electronic means.

6. The NATIONAL MUSEUM OF THE PHILIPPINES will hold a Pre-Bid Conference on 4 March 2022, 9:30 A.M. at Old Civil Service Building, National Museum of the Philippines, Padre Burgos Street, Manila which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below. LATE BIDS SHALL NOT BE ACCEPTED.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

9. Bid opening shall be on 18 March 2022, 9:30 A.M. at Old Civil Service Building, National Museum of the Philippines, Padre Burgos Street, Manila. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

10. The NATIONAL MUSEUM OF THE PHILIPPINES reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
