The NATIONAL MUSEUM OF THE PHILIPPINES will hold a Pre-Bid Conference on 16 June 2022, 9:30 A.M., at the address given below which shall be open to prospective bidders.</p> <p>7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below. LATE BIDS SHALL NOT BE ACCEPTED.</p> <p>8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.</p> <p>9. Bid opening shall be on 29 June 2022, 9:30 A.M. at the address given below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.</p> <p>10.
