

**RESOLUTION No. 2022 - 28**

**DECLARING TEKZONE COMPUTER SALES AND SERVICES, INC., WITH THE THIRD-LOWEST CALCULATED AND RESPONSIVE BID FOR THE LOT 2: PROCUREMENT OF LAPTOP (TECHNICAL USER), RECOMMENDING APPROVAL OF AWARD**

**WHEREAS**, the National Museum of the Philippines (NMP), through the Bids and Awards Committee (BAC), intends to acquire, by means of Public Bidding, a bonafide merchant for the project mentioned above;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **Three Million One Hundred Fifty Thousand Pesos (PHP 3,150,000.00)** chargeable against General Fund FY 2022;

**WHEREAS**, on 22 February 2022 the National Museum of the Philippines (NMP), through the Bids and Awards Committee (Committee) an Invitation to Bid was posted and published in the Philippine Government Electronic Procurement System (PhilGEPS), NMP Website, and in the BAC Bulletin Board;

**WHEREAS**, four (4) observers from various government offices and private organizations were invited to witness the bidding process, *viz* Commission on Audit (COA); National Historical Commission of the Philippines (NHCP), Philippine Chamber and Industry Plaza, Institute of Politics & Governance, Inc., and Museum Employees Organization (MUSEO);

**WHEREAS**, on 2 March 2022 a Pre-Bidding Conference was held at the Old Civil Service Building, Padre Burgos Street, Manila to discuss all matters pertaining to the aforementioned project, i.e. Terms of Reference, Scope of Work, Bidding Documents, and others;

**WHEREAS**, on 16 March 2022 the Committee conducted the Submission and Opening of Bids, at the Old Civil Service Building, Padre Burgos Street, Manila, attended and participated by three (3) interested bidders, namely:

**WHEREAS**, in NMP BAC Resolution No. 2022 - 22 & 25, Quartz, and Freshmango bid documents were found post-disqualified and not responsive by the Technical Working Group (TWG); (Please see attached copy attached as Annex "A")

**WHEREAS**, the TWG initiated the same post-qualification process to Tekzone, as the 3<sup>rd</sup> LCB and found that the documents submitted by the latter complied with all the technical, financial, and post-qualification requirements and conditions set for the aforementioned project;

**NOW, THEREFORE, WE**, the members of the Bids and Awards Committee hereby recommends as we hereby **RECOMMENDS** that the project, **LOT 2: PROCUREMENT OF LAPTOP (TECHNICAL USER)**, be awarded to **Tekzone Computer Sales and Services, Inc.**, with a contract amount of **Three Million One Hundred Thirty-Two Thousand Eight Hundred Pesos (PHP 3,132,800.00)**.
