Delivery of the Goods and Services is required within Thirty (30) Calendar Days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.</p> <p>Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.</p> <p>4. The NATIONAL MUSEUM OF THE PHILIPPINES will hold a Pre-Bid Conference on 26 July 2022, 9:30 A.M. at the address given below which shall be open to prospective bidders.</p> <p>7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below. LATE BIDS SHALL NOT BE ACCEPTED.</p> <p>8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.</p> <p>9. Bid opening shall be on 9 August 2022, 9:30 A.M. at the address given below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.</p> <p>10.
