CONTRACT AGREEMENT

THIS AGREEMENT made the 18 JUNE 2022 20__ between
**NATIONAL MUSEUM OF THE PHILIPPINES, National Museum Complex, Rizal Park,
Manila, 1000, Philippines** (hereinafter called "the MUSEUM") and **MIM Precision
Instruments Trading, 2 Balas St., Bryg. Culis, Hermosa, Bataan** (hereinafter called "the
SUPPLIER");

WHEREAS, the MUSEUM invited Bids for certain goods and ancillary services, viz.,
particularly **Supply and Delivery of Dehumidifiers for the National Museum of the
