PROJECT PROFILE

TITLE: Preventive Maintenance of Fire Sprinkler System at National Museum of Fine Building & National Museum of Natural History Building.

LOCATION: NMNH and NMFA Ermita, Manila Arts

IMPLEMENTING UNIT: Facilities Management Division (FMD)

DESCRIPTION: The National Museum of Fine Arts (NMFA) and National Museum of Natural History (NMNH) Buildings were equipped with a Fire Sprinkler System which are intended as one of the main lines of defense during fire incident. Upon our assessment, there is a need to conduct leak test by air charging of the riser, branches and sprinkler head lines to ensure integrity of sprinkler lines before filling up with water.

OBJECTIVE: To maintain the effective performance and operations of the Fire Sprinkler System of the NMFA and NMNH Buildings, also to provide a satisfactory and safe physical environment for the public and the National Museum collection.
