- 1. The National Museum of the Philippines (NMP), through the General Fund FY 2022 intends to apply the sum of Two Million Five Hundred Seventy Thousand Pesos (PhP 2,570,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the above mentioned project. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
- 2. The NMP now calls for the submission of eligibility documents for the above- mentioned project. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before 3 November 2022, 9:30 AM at the address given below. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion. Late bids shall not be accepted.
- . Interested bidders may obtain further information from NMP Bids and Awards Committee (BAC) and inspect e Bidding Documents at the address given below from Mondays Fridays at 9:00 A.M. to 3:30 P.M.
- 4. A complete set of Bidding Documents may be acquired by interested Bidders on 26 October 2022 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Two Thousand Pesos (PHP 2,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of three (3) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

Bidding will be conducted through open competitive bidding terion as specified in the IRR of RA 9184. procedures using non-discretionary

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations

with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

- The NMP shall evaluate bids using the Quality-Cost Based Evaluation (QCBE), (Technical: 85% and Financial: 15%). The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
- 8. The contract shall be completed within One Hundred Twenty (120) Calendar Days reckoned from the date stated in the Notice to Proceed (NTP).
- The NMP reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
